

**Donate a minimum of \$1,000 by December 22, 2025 and receive 50% of your gift back in the form of a Missouri tax credit.**

The Care Service has a limited amount of Missouri **Neighborhood Assistance Program (NAP)** Tax Credits remaining available to eligible donors for donations made to our NAP project during 2025. These tax credits are available on a first-come, first-served basis.

Please note that donations must be dated by **12/22/2025**. **Please give us a call to confirm availability.**

Donations to NAP program allow The Care Service help our neighbors like Ernestine and her two grandkids, who needed just a little bit of help to get on their paths toward a new beginning.



### Eligibility

If you are a **business** or have **business income** and make a donation of **\$1,000 or more** to The Care Service identified for our NAP project, you will receive a Missouri state tax deduction equal to **50% of your eligible contribution**.

Eligible income types:

- Farm income
- Rental income
- Royalty income
- LLC or partnership income
- Sole proprietorship income
- S-Corp income

Donations from corporations are also eligible for NAP tax credit.

### Procedure

To make a donation eligible for the NAP Tax Credit, please follow one of these methods:

- **Mail a Check:** Send a check to The Care Service, 4116 McClay Road, St. Charles, MO 63304. In the memo line, please note "NAP Tax Credits."
- **Donate Online:** We accept both credit and debit cards. Select "Area of Greatest Need" from the Campaign drop-down menu, and be sure to check the box to leave a comment, writing "NAP Tax Credits."

- **Cash Donation:** Visit our office and ask to speak with Mary. Be sure to mention that your donation is for NAP Tax Credits.

### **What are NAP Tax Credits and how do they work?**

The State of Missouri grants certain non-profit agencies limited amounts of tax credits that are then offered to their donors in exchange for monetary donations. The Care Service has 50% NAP tax credits available to donors who make a minimum contribution of \$1,000.

Eligible Missouri taxes include individual and corporate income tax, partnership income tax, and franchise tax among others.
